CIP Explanation Request:

The Request –

"Before we get too far into the CIP season, I'd like to make an advanced request that the committee be given details on small equipment in the police department. There are items such as firearms, vests, tasers and the like, which are associated with each officer. I hope that the committee can gain an understanding of how such items are allocated. I would assume that tasers and firearms belong to the department and would be turned in when an officer left, and subsequently reissued to any newly hired officer. It is my understanding that vest are custom made to fit an officer. If that is correct, is the officer allowed to take the vest with them if they are going to the PD in another town? Conversely, do some officers come complete with a vest if they are hired from another town? With firearms, how long are they kept before replacement and how is that determination made? I can imagine that range practice must be required and so how many times are weapons actually fired and does that contribute to a need to replace them? If the chief can be prepared to address these question when the PD comes to CIP this summer, it would be appreciated."

The Response -

In answering the above request, The TASER and Firearms are Town Departmental Property. When an officer leaves, these items are inspected, cleaned and updated respectfully so when a new officer joins the PD these items are in excellent working order.

With the BPV's Mr. Fluery, you are correct each vest is measured specifically for the officer, we have a 3 year contract in which an officer agrees to work for the town, if an officer leaves prior to that for another agency we offer to the vest to the new agency for a prorated price, sometimes that is an agreement we can come to depending if the new agency wears the same style vest. If the vest if fairly new and the other agency is willing to sell it to us then yes we offer to purchase it. If not, we use them for ride-a-longs, internships and training. All vests have a 5 year life. The vests are primarily taken out of uniforms line item due to the staggered purchases of them.

Cruiser Vests Panels are replaced every 5 years, the initial purchase was costly due to outfitting each cruiser designed to as a one size fits all. The panels only are the reoccurring cost with this item. This has become a fractional in price for replacement cost.

Firearms, we work with an FFL who will give us the best deal, we research the guns themselves as well as ammunitions available and chose the best options based on the NIJ-DOJ. The department does training throughout the year anywhere from 250-1000 rounds each depending on the training. The cost of replacing the firearms is offset by the FFL purchasing our old department firearms. The firearms are replaced based on manufacturer suggestions, new model firearms, wear & tear, currently our firearms are 2 years old, they are the Glock 17 9mm. They replaced the Sig P229 .40 caliber after about 16 years carrying them. Each firearm gets a full inspection every 2 years or 5000 rounds, replacement of parts if needed at this time.

The TASER is a big item that is carries a one year manufacture warranty, we purchase the extended full warranty to cover the cost of the replacement since the warranty price for the 4 extra years is fraction of the cost of a new TASER. These items are usually replaced every 5 years as there is a new model introduced around that time frame. Once a new model is introduced then the current model will no longer receive updates or repairs after the warranty period.

CIP Request Explanation: 2024 Police Cruisers

The department currently has 8 police cruisers, two unmarked (1 Admin & 1 Investigations) the remainder are marked fleet vehicles.

Personnel are assigned to each car and monitored for wear and tear, Changes can be made depending on Mileage and shift. This extends the life of the fleet.

The Town Public Works Departments conducts maintenance service, as well as most minor repairs not covered under warranty.

Major repairs and Warranty work are completed at the dealership.

Local businesses take care of other basic maintenance.

Currently each Cruiser comes with a standard 3yr/36,000 mile bumper to bumper warranty as well as a 5yr/100,000 powertrain warranty.

Cruisers are purchased by dealerships honoring State Bid Pricing.

Pricing is not available until the earliest August, for the 2024 vehicle the vehicle has a 5%-7% increase suggested by the dealer to cover the difference.

Equipment Pricing as well has risen with a 10% increase as suggested by equipment installation contractors. Due to the unknown of model availability.

Graphics have increased but is included in the cruiser equipment add on.

One car purchased last year lucked out with inventory at Mass Dealership.

History only purchasing cruisers when necessary.

We include all of our equipment with anticipated replacement costs beyond the five year scope of the CIP due to their acquisition costs. The costs are high and the Town should anticipate these costs.

Section II describes what the function of each unit is as background and justification for it's funding.

<u>Section III</u> is our SMALL EQUIPMENT RESERVE FUND and any other items funding is being requested for.

Section II - Major Equipment Fund Explanation

Included in this section is all of our motorized equipment.

Our structural fire fighting equipment consists of:

ENGINE 1 Primary response vehicle for fires and other emergencies. Role is to carry personnel, fire fighting equipment, hose, water and a large volume fire pump for water

supply. Provides transportation for six firefighters.

ENGINE 2 The roles and capabilities are the same as Engine 1. As Engine 1 ages we will use Engine 2 as the primary response engine. Engine 2 Carries 1500 gallons of water.

TOWER 1 75' aerial tower used primary to provide firefighters with access to difficult locations at an emergency. Secondary role is removal of people from heights or below grade. Also provides high volume fire flow from aerial itself.

RESCUE 1 Specialty support vehicle that transports our breathing air replenishment system, technical rescue tools such as jaws of life type tools, ropes, extrication tools, etc. Provides transport of 5 people. Also used as an on scene command center if needed.

Our utility emergency fire fighting equipment consists of:

UTILITY 1 A 3/4 ton pickup truck purchased in 2003, Primary use is to transport people and equipment. Also used for snow plowing safety center.

BOAT 1 An inflatable boat with motor whose primary role is for water emergencies on the Merrimack River.

Utility trailer with large generator set used to provide on scene lighting. This unit is LIGHTING 1 also used by other town departments if needed.

CAR 1 Repurposed Police Vehicle, Used for Incident Command. Life Safety Inspections. Response to Medical Calls to assist the Ambulance. Not listed in CIP. Plan would be to replace with Cruiser going out of service.

Our forestry fire fighting equipment consists of:

FORESTRY 1 Off road forest fire vehicle used in direct fire attack. Crew of two.

FORESTRY TANKER 1 Large off road water tanker. State owned but Town maintained.
