A. Approval of Minutes / Financials

D. LL Building – Drainage - Matt P, president of LL, contacted Rose about drainage issues with the sink in the building. Last year the town had a plumber look at it and he did not know where the pipe drained into. He suspected thaty LL just had it drain into the ground. LL had a volunteer snake out pipe and found the pipe exiting out the building but does not know where it leads to. They had an inspector from EDR Inspections to come out on June 19 to use a small excavator to dig up more ground to see where the pipe goes. Cost would be around \$500. It was determined that the area needs a new holding tank or to connect pipe to septic. Dana explained why it would not be a good idea to run pipe to septic. Matt P. says he has a LL representative with construction background that will contact DES to see what permits are needed. Matt will get estimate of the cost with detailed break down of what has to be done.
